Message from the Chair & Executive Director

The past 13 months have presented all of us in the commercial real estate industry with unprecedented challenges. As the pandemic hit, BOMA members were at the forefront of the response. You assisted tenants in understanding the restrictions, accessing government support programs, and making rent payments. You also adjusted policies and protocols to ensure that buildings were distanced, cleaned, and safe. You rose to the occasion for your tenants, your organizations, and to support the important collective effort in stopping the spread.

For us at BOMA Calgary, the challenges we face have likewise forced us to re-imagine our role and the ways in which we provide value to the industry and those who comprise it. Our role as an association boils down to three key pillars: advocacy, education, and professional networking. While social distancing requirements have made action in these areas difficult, it was quickly apparent that the three pillars would be even more important to the value provided to each BOMA Calgary member.

From the outset, the pandemic brought with it a level of government intervention and involvement in this industry in ways previously unimagined. Throughout, BOMA Calgary has been representing the industry as governments enact wide-ranging policies that impact members. This includes senior-level advocacy on the previous Canada Emergency Commercial Rent Assistance Program (CECRA), the Canada Emergency Rent Subsidy (CERS), and the Provincial Government's Bill 23.



As important as all of this work with senior levels of government has been, BOMA Calgary's involvement as an invited partner at the the Calgary Emergency Management Agency's (CEMA) Emergency Operations Centre (EOC) has been equally valuable in ensuring our industry' voice is heard, and that our needs are considered as the City responds with its own actions, including +15 closures, elevator restrictions, signage, and vulnerable populations.

Education also remained a priority, and the ever-shifting rules meant that BOMA Calgary had a key role to play in curating the most important and relevant information to share with the membership through sessions such as the two Return to Work Townhall sessions hosted in June, and September.

Professional networking as we have come to commonly understand it was a significant challenge, but it doesn't mean it can't be done. While nothing can replace mixing and mingling at a signature BOMA event, 2020 still provided opportunities for those in the industry to meet new industry colleagues at events like the TC Energy BOMA Excellence Award, as well as the magic of a BOMA Christmas Luncheon as Chris Funk awed guests with a live, interactive magic show that brought the industry together to celebrate the season.

So while we are exceptionally proud of the way we responded to the pandemic and delivered value to the membership through these tough times, we are excited to take these learnings into 2021 and beyond to continue on our mission to be the pulse of commercial real estate in Calgary.



- Through the pandemic, BOMA Calgary and our industry partners have been at the table representing the industry as the municipal, provincial, and federal governments have enacted policy and legislation that directly impacts the commercial real estate industry.
- BOMA Calgary and our partners have also been active throughout the pandemic in working with the provincial government, including important advocacy on issues like evictions moratoriums and tenant relief.
- BOMA and our industry partners continue to engage with senior levels of the federal government advocating for quick fixes to the Canada Emergency Rent Subsidy (CERS) that will support tenants and ensure more businesses have access to the benefits.
- BOMA Calgary met with the Honourable Jim Carr, Special Representative to the Prairies, as part of the federal pre-budget consultations process with representatives from the commercial real estate industry.
- BOMA Calgary met Doug Schweitzer, Minister of Jobs, Economy, and Innovation as well as Invest Alberta to highlight the role of the CRE industry in Alberta in attracting investments to the province.
- BOMA Calgary is a key stakeholder as the City and Province move forward on the Green Line LRT project, and together with industry partners successfully advocated for improvements to the final plan.



- BOMA Calgary was a key stakeholder in development of the revamped Real Estate Council of Alberta (RECA), and forcefully advocated for more fair representation for the commercial sector.
- We are currently working with the City of Calgary's Building Maintenance Bylaw team to develop and distribute an education supplement on the benefits of current program, while ensuring the scope of the bylaw isn't drastically expanded.
- As members of the City of Calgary's Climate Panel, we are working with the City of Calgary to develop a climate adaptation plan and provide industry feedback to the City's initiatives and direction
- We are engaging with the Safety Codes Council to clarify and seek a solution to the problematic 2018 changes to out of operation escalators that is negatively impacting industry members
- Members of the Government Affairs Committee provided written feedback to the City of Calgary on the Stephen Avenue revitalization project plan, including highlighting concerns and opportunities for the project.
- We were engaged with the City of Calgary's Financial Task Force on recommendations and strategic direction.

BOMA Calgary remains an invited member of the Calgary Emergency Management Agency (CEMA)'s Emergency Operations Centre as the City addresses the COVID-19 Pandemic. To date, we've sent 15 pandemic related updates that impact our members.

- BOMA Calgary supported the City's development and launch of the voluntary Commercial Building Energy Benchmarking Program.

- Building Operator Program successfully trained 14 students virtually for the first time.


